He said since they started this program, along with several other ones where they partnered with private businesses and non-profits they have raised over \$35,000 in a little over 3 ½ years.

Mayor Judge stated there are a few construction projects that started today. He said one is the sidewalk program - they are putting in a sidewalk along Norton Avenue from 5th Street to the drive entrance of Stark State. He said they have been working with Metro Bus and they will be putting in a bus stop/pad.

Mayor Judge said they are working on a project on the corner of Paige and 2^{nd} Street – downtown where K's Candies use to be.

Mayor Judge stated the upcoming Saturday is Trick or Treat from 5 pm to 7 pm. He said to be careful with all of the little ones running around.
