Mr. Megyes said he is having a ward meeting tomorrow, October 9th, at the Active Adult Center for the Van Hyning Neighborhood Watch Group. He said Mr. Stefan and Officers Mike Green and Marty Eberhart will be there to address some concerns in that neighborhood.

Mr. Wagner said he has visited the Seiberling project and he wanted to bring Council up-to-date. He said his biggest fear came true -- the workforce is from south of the border and there are men and women on the project. He said the guy stood right here and told us how he bid this job -- how he missed the duct work and some other things. He said #1, there is no power out there. He said the spec stated you had to provide generators to provide the power. He said he threw a fit over generators because he did not want to provide them -- he wanted the City to pay for power to come into the plant. He did not get it. He said the other issue was no water. He said you have to come in to fill out a permit, tap onto a fire hydrant, etc. He said the water cannot be turned on out there because there are probably so many leaks it would be like a sprinkling system. He said he is also very concerned with the way they are abating the asbestos. He said that is all he can say at this point.

President Maurer said he appreciates Mr. Wagner's observations because Mr. Wagner has an eye for these things. He said he hopes it does not become a serious problem, although it sounds as if there are already problems. He said working for the power company, he knows that it takes weeks to get electric power. Mr. Wagner said if he had read the spec, he would have known that he had to provide generators.

COMMUNICATION FROM THE MAYOR

Mayor Judge said he would first like to thank Council for supporting the School Levy. He said he respects everyone's opinion with that issue. He said schools are one of the most important factors in the success of a city, especially in a small city like Barberton.

Mayor Judge said he would also like to thank Council for passing the \$100,000 appropriation for New Haven Development. He said putting those funds into a special account will allow them to have a better oversight over the money and to be even more transparent to the public of how that money will be spent.

Mayor Judge said this Saturday the Barberton Community Foundation is having a retreat in Akron. He said he will be there, along with President Maurer and Mr. Avant.

Mayor Judge said the Barberton Community Foundation has a new website that it is pretty nice. He said everyone should check it out.

Mayor Judge said the Health Fair is October 25th for city employees at the Active Adult Center (YMCA). He said to stop in at the Human Resources Department if anyone needs more information or has any questions.

Mayor Judge said they played Alcoa in softball this past Saturday for charity. He said over \$2,500 was raised for diabetes. He said the City again beat Alcoa! He said they would be playing Alcoa in flag football with the donations going to Toys for Tots in December.
