If a Multi-Family Apartment, Commercial, Industrial or Institutional User, who discharges sanitary sewage into the City's sewage collection system, is not a user of water supplied by the City, and it is not measured by a City water meter or by a meter acceptable to the Superintendent of Utilities, the Superintendent of Utilities shall estimate the usage in gallons per month of sanitary sewage discharged into the City's system or shall require the installation of a meter to measure such usage and a Sewer Service Charge and Use Charge shall be billed to the User at the rate set forth.

Flat rate customers may choose to have a water meter and meter interface unit installed acceptable to the Superintendent of Utilities at the owners expense at the water service entry point into the building being served and will be charged the applicable metered rate for sanitary sewer services.
