#### **SCOPE OF WORK FOR BID**

INSTALLATION OF (178) UNITS OF LED LAMP #SBL-500W12-55K-E32-G2 -RETRO-FIT LAMP/LIGHTING KIT TO INCLUDE SCREW-IN (E39) MOGUL BASE LED LAMP UNIT WITH REMOTE POWER SUPPLY OR AN APPROVED ALTERNATE (E39) MOGUL BASE LED LAMP AND REMOTE POWER SUPPLY PRODUCING A MINIMUM OF 82,500 LUMENS (CCT OF 5000K TO 5500K ACCEPTABLE), 480V DRIVER, MOGUL BASE, UL OR ETL LISTED, LM79 & LM80 TESTED, WITH A MINIMUM 5 YR/50,000 HOUR WARRANTY. ALTERNATE LAMP CUT SHEET TO BE INCLUDED WITH BID. THESE UNITS ARE TO REPLACE (178) EXISTING METAL HALIDE LAMPS MOUNTED IN EXISTING FIXTURES ON POLES THAT ARE APPROX. 65FT HIGH. THESE WILL PROVIDE NEW LIGHTING FOR 4 BASEBALL FIELDS. PROJECT INCLUDES REWIRING OF EXISTING LIGHTING FIXTURES TO ACCEPT EXTERNAL LED POWER SUPPLY IN BASE OF EXISTING LIGHT POLES. EACH LAMP TO BE REWIRED TO BYPASS AND REMOVE OLD BALLASTS AND OLD METAL HALIDE LAMPS. The City intends to open the bid responses to this Invitation to Bid (hereafter called ITB) on March 11th, 2022 and to select qualified vendor(s), if any.

#### A. <u>INTRODUCTION:</u>

#### 1.1 Purpose/Objective

The City of Barbeton (hereafter called the City) is seeking installation of Foundation energy efficient LED lighting for the **Fields** has determined Complex. The City that it is desirable solicit to bids from interested and qualified vendors/contractors to install energy efficient LED lighting at the (4) baseball fields at 841 Wooster Rd. using specifications set LED lamps with forth in Appendix In addition, the vendor will be responsible for any damage to building or site, and site cleanup.

#### **B. GENERAL DESCRIPTION OR REQUIRED PERFORMANCE OUTCOMES:**

#### 2.1 Anticipated Services to be provided under this ITB

Successful Bidder will be expected to install LED lighting retro fit units throughout: Foundaton Fields Baseball Complex

In addition, to remove and rewire the existing sports lighting fixtures to accept direct line power (480V) and replace 178 metal halide lamps with 178 new LED retrofit lamps and bypass the current ballast/power supplies and installing a remote external LED power supply to each of the existing lamp heads in the base of the existing poles. Specifications for all LED units to be used by the successful bidder are set forth in Appendix A. Poles are approx. 60-65 feet high. Successful bidder must properly and legally dispose of the existing metal halide lamps (containing mercury) as described by the EPA and Federal Laws.

#### 2.2 Scope of Work

Contractor must provide any and all equipment and material to perform necessary services. Services identified in 2.1 above will include removal and disposal of old ballasts, metal halide lamps, all site cleanup at each field location and installation of LED lighting. The contractor will also be held responsible to repair any damages occurred during the installation process.

#### **C. SPECIFIC REQUIREMENTS:**

- 3.1 The Contractor agrees to provide services to the City as an independent contractor and not as an employee, as those terms are understood for Ohio and Federal law purposes. The Contractor agrees to provide for, secure, and/or be solely responsible for any and all required fees, permits, Workers Compensation coverage, Unemployment Insurance, Disability Insurance, Social Security contributions, income tax withholdings and any other insurance or taxes, including but not limited to Federal and income taxes, for any persons performing services pursuant to a subsequent agreement, including the Contractor, and any employees of the Contractor. The Contractor agrees to indemnify the City and hold the City harmless form any claims, suits, losses, or damages, including reasonable attorney fees, resulting from any failure on the part of the contractor to satisfy its obligations as stated herein.
- 3.2 The Contractor acknowledges and agrees to purchase, register and insure any and all necessary equipment and vehicles to provide the scope of services identified. Automobile liability insurance must have a minimum limit for bodily injury and property damage of \$1,000,000/\$3,000,000.
- 3.3 The contractor acknowledges and agrees to purchase comprehensive general liability insurance with minimum liability limits of \$1,000,000/\$3,000,000 for personal injury and property damage, and \$3,000,000 aggregate to protect against claims brought against the City, which may arise from the provision of services under a subsequent agreement. Contractor agrees to name the City as an additional named insured.
- 3.4 The Contractor agrees to indemnify the City and hold the City harmless from any claims (including but not limited to claims under Ohio Labor Law if applicable), suits, losses, or damages resulting from or relating to any services provided by the Contractor and/or equipment or materials used by the Contractor, or any other person performing services pursuant to a subsequent agreement. Any and all employees or subcontractors working under Contractor must be trained and instructed under requirements of Ohio law. The Contractor shall be liable to the City for any loss, damage or destruction or any property, materials, goods, documents, or other items, including reasonable attorney's fees, resulting from or related to the negligence, or other wrongful acts of the Contractor, the Contractor's employees, or any other person performing services pursuant to a subsequent agreement.

- 3.5 The Contractor may not assign, transfer, sublet or otherwise dispose of the Agreement without the prior written consent of the City.
- 3.6 The City reserves the right to require additional contractual provisions it deems appropriate to give effect to this Proposal.

#### D. ELIGIBLE APPLICANTS:

4.0 To be deemed an eligible applicant, you must have properly registered with the City of Barberton and have insured equipment, and be licensed (if required) to operate said equipment. Bidder must also be a licensed electrical contractor with the State of Ohio.

#### E. PROPOSAL FORMAT:

5.0 To be submitted on your own forms, but must include the non-collusion form, corporate form set forth at the end of this ITB.

#### F. BASIS OF AWARD:

- All proposals will be evaluated to determine if they meet the requirements of the Request for Proposals. The City may, as it deems necessary, conduct discussions with the contractor(s) it deems reasonably suspected of being selected for award, for the purpose of clarification and responsiveness to requirements. The City may assign varying weight to criteria, and reserves its right to make an award based upon "best value" criteria.
- 6.2 Information gathered by the City from the City, during any interviews, and any other information and factors deemed relevant by the City may be considered in a final award. Some additional information and criteria the City may consider includes, but is not limited to the bidder's reputation (of the contractor), commitment to quality of services, responsiveness.
- 6.3 The City reserves the right to accept or reject any and all ITB's, and to select proposals for award other than those with the lowest price(s) in consideration of best value and best interests of the City.
- 6.4 The Award may be made to the most responsible bidder whose bid is determined to be in the best interest of the City of Barberton, and deemed to best serve the City's needs and requirements, based on the evaluation of all information provided including an interview with Contractor and the Award Committee.
- 6.5 The award shall be made by best value, and must be in the best interest of the City. The City reserves the right to reject any and all bids and to waive any informality in bids received whenever such rejection for waiver is in the interest of the City. Price will not necessarily be the determining factor in the award of the contract. The bid award will be in the best interest of the City for approval. Contract award will be made by the City of Barberton.
- 6.6 Contractors will be notified in writing of the successful award after formal acceptance by the City of Barberton.

#### **G. CONTRACT PERIOD:**

7.1 Initial contract period shall be determined relative to the date of proposal acceptance, City calendar and any other relevant terms or conditions. It is the intention that the entire project be completed by the early Spring of 2022.

#### H. GENERAL INFORMATION:

#### I. PROPOSAL FORMAT:

Your proposal can be submitted on your own form, but must include the following to be considered:

- 1. Name, Address, Contact Person.
- 2. Telephone Number/Fax Number/E-mail Address.
- 3. Years of experience, if any, in commercial electrical/lighting retrofit services.
- 4. Description of equipment intended to be used for the project.

#### II. PROPOSAL REQUIREMENTS:

- 1. Proposals must be accompanied by a signed Proposal From, signed Non-Collusion Statement and signed attestation of Good Standing, if corporate entity. These forms can be found at the end of these specifications.
- 2. Provider must submit their written proposal on their own forms.
- 3. One original and four (4) copies of the proposal must be provided.
- 4. Read all documents contained in the proposal package.
- 5. Proposals must be submitted to:

- 6. To be considered, the proposal must be received no later than 1:00 p.m. on February 12, 2021. No proposals will be accepted after the designated time.
- 7. Providers shall indicate on the outside of their sealed proposal the following information:
  - a. Title of Bid (Barberton Foundation Fields Bid, Lighting Upgrades)
  - b. Company Name/Bidders Name

Failure to do will result in the rejection of the bidders proposal.

#### III. LATE PROPOSALS:

Proposals received after the date and time prescribed shall not be considered for contract award and shall be returned, unopened to the Contractor.

**NOTE:** Any delay due to traffic, weather, mail or express delivery is not an exception to the deadline for receipt of proposals. Please plan accordingly.

#### **IV. NON-COLLUSION STATEMENT:**

A signed Non-Collusion Statement shall be returned will your proposal.

#### V. PROPOSAL CONTENT:

All information required by these specifications must accompany the proposal or provider may be disqualified.

#### VI. ADDENDA:

Addenda are written instruments issued by the City prior to the date for receipt of offers which modify or interpret the specification document by addition, deletion, clarification or correction.

Addenda will be mailed, emailed or faxed to all who are known by the City to have received a complete set of specification documents. No addendum will be issued later than forty-eight (48) hours prior to the date and time for the receipt of offers, except an addendum withdrawing the ITB, or addendum including postponement.

#### VII. PROPOSAL RECEIPT BY A THIRD PARTY:

Any Contractor submitting a proposal based on incomplete or inaccurate information resulting from documentation received from any third party shall not have cause for relief from award or completion of a contract in accordance with the official documents on file with the City of Barberton.

The City does not officer or supply anyone the list of people that have obtained a copy of these ITB specifications for the project prior to opening the Bid. NO EXCEPTIONS ARE MADE TO THIS POLICY.

#### I. CONFLICTING TERMS:

8.1 The requirements provided in the "specification" portion of these documents shall govern in any conflict with any other language provided in the general "Terms and Conditions" or any other boilerplate type information. Any conflict between the specification language and any boilerplate language will be resolved in favor of the specification language.

#### J. EXECUTORY CLAUSE:

9.1 Any contract offered in response to this ITB shall contain the following clause: "This Contract shall be deemed executory only to the extent of funds appropriated by the City of Barberton and available for the purposes of this Agreement; and no liability on account thereof shall be incurred by the City of Barberton beyond the amount of such funds."

#### **K. NO JOINT BIDS:**

10.1 Joint Bid/ITB's will not be accepted. For purposes of the specifications, the term joint Bid/RFP shall include, but is not limited to, any Bid/RFP submitted jointly by two or more Contractors in the name of partnership, joint venture or other legal entity formed for the purpose of submitting such a Bid or to be formed for the purpose of entering into a contract pursuant to such Bid.

#### L. PAYMENTS UNDER CONTRACT AWARD:

11.1 Payments will be made by the City after perscribed services have been rendered and are complete. Payment will be made 45 days upon submittal of completed work and completed invoice. Any claim against the contract may be deducted by the City from any money due him in the same or other transactions. In any case where a question of non-performance of a contract arises, payment may be withheld in whole or in part at the discretion of the City as compensation for any loss, damage, or cost incurred by the City as a result of said non-performance.

#### M. CONFLICTS OF INTEREST:

12.1 In executing and submitting this Bid, the bidder represents and warrants that no person who is an elected official, officer, or employee of the City of Barberton, not any person whose salary is payable in whole or in part, by the City or any corporation, partnership or association in which such official, officer or employee is directly or indirectly interested, shall have a financial interest, direct or indirect, in the contract to be awarded hereunder or in the proceeds thereof, unless such person completes and submits a Disclosure Form, on a form acceptable to the City, disclosing their interest or seeks a formal opinion form the City of Barberton as to whether or not a conflict of interest exists. For a breach or violation of such representations or warranties, the City shall have the right to annul this Agreement without liability entitling the City to recover all monies paid hereunder and Contractor shall not make claim for, or be entitled to recover, any sum or sums otherwise due under any contract awarded hereunder.

#### N. FEDERAL DISBARMENT DISCLOSE REQUIREMENT (MANDATORY)

13.1 All bidders, contractors, sub-contractors and equipment vendors must show proof/documentation that none of those entities are on the Federal Debarment List (SAM.GOV). This disclosure is mandatory to be to be considered for project award.


