## **COMMUNICATION FROM THE MAYOR**

The Mayor stated that on February 16, 2022 PBS will be airing "Road Foods". This is a series where they spotlight communities and their ties to an ethnic food dish. Obviously here in Barberton we have fried chicken fries, coleslaw and hot sauce. This was taped here in October, 2021.

Change for Change will be this Thursday at Angie's benefiting Girls On The Run.

The monthly update on the Cox-Powell building is that we have received the financial incentive from Summit County. We received half of it at the end of last year and the other half this year. We have met with the Developer regarding the Development Agreement. We also have a meeting set up with the Summit County Land Bank who is also involved in this project. More information will be shared next month.

The Mayor stated he is continuing to work on the 2022 Budget. There have been some setbacks as he has shifted some meetings around. He is hoping to get this to the Finance Department at the end of the week. Hopefully sometime next week it will be delivered to Council. As with previous years, the Mayor will contact Department Heads to have them come and describe their department and be available to answer any questions.

The Mayor wanted to remind everyone that there will be no Council Meeting next Monday as it is the fifth Monday of the month. Our next meeting will be February 7<sup>th</sup>.

Mrs. Frey stated that she had talked with President Greer and the Clerk of Council, and because of how Council meets it might be possible that the Committee of the Whole meetings are a little shorter right now and possibly we could have our budget meetings on those evenings to hasten the process. The Mayor stated that he could talk to some of the Department Heads whose budget portion is not as in-depth and have them come and get their portion handled.

## **CLOSING REMARKS**

President Greer stated that over the weekend Council met in a Special Session to interview and appoint a Councilperson for the vacancy in the First Ward. Mrs. Bailey is here in the gallery and was the chosen appointee for the Ward One seat. President Greer was thrilled and stated that she was more than qualified and that Council feels she is the best candidate for the job. Council is excited to begin working with Mrs. Bailey. Mrs. Bailey is currently getting things set up for her swearing in and will be all set and ready to go for the February 7<sup>th</sup> Committee of the Whole Meeting.

Also, as mentioned previously, if anyone has ideas for changes, please contact President Greer, Mrs. Frey, or the Clerk of Council. Some changes may require a change to the City Charter so we will need to get them in draft format to begin discussion on them.

President Greer also wanted to say that the Street crews are doing an awesome job during this winter storm. Council applauded and agreed. Interim Service Director Todd Shreve stated that he talked to this afternoon and that 6 men will be held over during the night to keep up with the road plowing. In the morning time there will bring many changes.

As the Mayor mentioned the 31st is the fifth Monday so Council will not be meeting.

It was moved by Mr. Heitic and seconded by Mrs. Thompson to adjourn. All voting "Aye" and none apposed.
