# MISCELLANEOUS AND UNFINISHED BUSINESS

Mr. Griffin stated he had a remote conference where he learned the black population in Ohio are really suffering because of the COVID-19, in fact all over the United States. He said a lot of it is hitting areas where most black people live and work. He stated 13% of the population is black and they represent 18% of the positive cases of the Corona Virus and 10% of the deaths. He said all of this is attributed to a lot of things – jobs they work in are service related – cooks, hospital orderlies, jobs where you can't work from home. He said they have to be on the front line, like a truck driver. He said they don't know what to do to change this but the ballot box is a place to start - if you don't support us, we won't support you. He stated they need to do better and there is a lot of money out there and he feels the city should look into the stimulus more and see what they might be able to do. He said the COVID-19 is going to expose the disparities and health care and the way people are represented.

President Megyes stated the next meeting will be in two weeks – April 27<sup>th</sup>.

Mrs. Frey thanked Justin and Renee for getting everything together and suggested to do more testing to work out the bugs. She asked if this is how all of the future meetings are going to be run. President Megyes stated this is the route they are taking.

President Megyes told everyone to keep their distance and to stay safe.

# **COMMUNICATION FROM THE MAYOR**

Mayor Judge stated with so much going on he appreciates all the hard work, termination and patience. He said they are getting through this but it is going to change the way they operate and change the way they look at things. He said there will be a lot of hard decisions that have to be made in the coming weeks and months. He stated there are so many variables and so many things out there that they will have to take into account to make those decisions. He said if

council members are out helping people or residents are calling them, to make sure they give his office the information, so when FEMA contacts them they could give them the appropriate numbers. He said FEMA came in and said the city had an EF1 tornado. He then said when they have a flood, they can say this affected 200 people, they want to see documentation. He stated if people have damage to their personal property, they may contact their insurance agency or their council person but they do not contact the city directly. He said it is very important to have as much information documented with a weather event.

Mayor Judge said they are continuing to work with Ohio Edison from the storm. He said all power has been restored. He said this is a hard time with people wanting to help but needing to maintain social distancing.

Mayor Judge stated there are multiple stimulus packages and programs being initiated and rolled out from the federal level to the state to the county and locally. He said they are moving very quickly, checks being dispersed, applications are given out and reviewed on a quick manner.

Mayor Judge said he and Mr. Flaker are constantly monitoring the income tax revenues sources and trying to do forecasting. He said it is not an easy thing to do when you have so many things going on. He stated he wants to have reports for council as soon as possible but they want to make sure it is the most accurate information. He said these are going to lead to decisions and those decisions are ones they will have to vote on and they will have to live with. He said he has conference calls a few times a week with department heads, with Congressman Tim Ryan, Senator Sherard Brown, Senator Ralph Portman and local State Reps. He said he had a conference call last week through the White House. He said hehas them with the county at least once, mostly twice a week which includes the Summit County Health and Emergency Management Agency. He said he spoke with The Cleveland Clinic and Akron General and he speaks with Dr. Hughes at Summa several times a week on getting updates. He said there is a lot of information flowing. He said they are trying to put as much information out as accurately and quickly as possible.

Mayor Judge said when they talk about income tax and forecasting, that is why he is always pushing on the reserves. He stated they can bring it up another time but the accounting report for the IAFF said that all the other funds are reserve funds and they can liquidate those to pay for the firemen but you can't. He said when you come up with things like what has happened and there are trees down in the parks, it becomes a safety issue, they have to scramble to bring the money together to get rid of those. He said they don't have the reserve fund because they have gone through that and they used it as it should have been. He said they are monitoring the municipality stimulus packages that are being talked about and lobbying for those but most of them are not free cash. He said there are strings attached or matching funds. He said he will be coming to council very soon with ideas that they are lobbying for.

Mayor Judge stressed the biggest thing right now is communication. He asked that council reach out to him because there may be programs available to businesses and residents.

Mayor Judge stated the utilities programs that were voted on earlier in the night – any expansion of water and sewer into another community, just not Norton, is great for growth in both communities. He said water and sewer is going to continue to be very vital and important for residential and commercial development moving forward. He said the EPA has been coming down hard on wells and septic systems. He said water and sewer is going to be liquid gold moving forward and he knows there is a lot of costs involved. He said it is important that council get involved and ask questions.
