COMMUNICATION FROM THE MAYOR

Mayor Judge stated the City of Barberton will be on a webinar later in the week regarding Economic Development, which is really changing, and the speculation on how that is changing and what this is going to look like after COVID. He said development has been suspended for a lot of different industries, what is retail going to look like, what are the restaurants going to look like. He said there has been talk about fast food restaurants going to drive-thru only to protect employees and customers. He said there a lot of talk out there so these webinars are very important as they speculate on what's going to happen.

Mayor Judge said he has four meetings set up with four different businesses in town that are looking to expand. He said he also trying to set meetings with four other businesses who have contacted his office through the Akron Urban League, Akron Score and a few other organizations.

Mayor Judge stated he will have his monthly meeting this week with BCDC and also NEFCO, which is a planning organization of four counties that the City belongs to.

Mayor Judge said there is a storm water meeting through Summit County Task Force that he sits on. He stated even though there is a dry spell and they haven't had any flooding; this is still a top priority not only here in Barberton but county wide and also regionally with the Governors' Task Force.

Mayor Judge stated he appreciates Council passing Resolution No. 72-2020. He said they have been continuing to work with ODOT on the AMATS money and projects that are coming to Barberton in the next few years. He said paving and actual construction doesn't happen for a year or two but they start the process now. He they are working with ODOT to get everything done so they get the project off without a hitch. He said if you have any questions, please ask. He said he appreciates the passage.

Mayor Judge echoed Mrs. Coburn announcement of Tavia Galonski's meeting.
