# **COMMUNICATION FROM THE MAYOR**

Mayor Judge stated the following Saturday he will continue with his open office hours at the Active Adult Center from 9am - 11am. He said he will adhere to social distancing and social mandates will be enforced.

Mayor Judge announced the Cancer Cures the Runner 5K will be held on the October 24<sup>th</sup> at the Wolf Creek Trailhead off of Snyder Avenue. He said it has been going on for a number of years and it is a great fundraiser for Relay for Life. He stated the organizers have been working with Summit County Health Department and all mandates will be enforced.

Mayor Judge said they have an important property levy on the ballot this year and any questions by the public can be sent to Yesissue9@gmail.com. He said this will generate about \$1 million if passed from the voters annually to the general fund. He stated there are a lot of communities that are on the ballot this November, as revenues are down and ours is for 3 mil, 3 years only. He said talking to residents, business owners, property owners and the press, they think it is important to note we are all committed to the 3-year time frame. He said once it expires, it expires and 3 mils, 3-years in comparison to other communities is a very short amount of time and also a small millage. He said it is important also to know how to read the property tax bill-look at the taxable value of your property, He stated they can run a calculation on this to determine what a 3mil increase would mean for the property. He said more information is getting out.

Mayor Judge said they had a resident send out an outline for housing and rental units that he had put together. He stated they have been working with him for a while on this going back to late last year and early this year and then when COVID hit, it put a lot of things to the side for a just little bit. He said he is working with the city's new BCO internally who has experience putting rental registrations programs together. He stated the city already has a program established and one of his first tasks is to review that and make recommendations. He said he will have recommendations prior to the end of the year. He said if you have any questions about the proposal or the current program, to reach out to him

Mayor Judge announced the COVID numbers continue to rise here in Summit County and throughout the State of Ohio. He said Summit County is at Level 2, which is orange and there are over 170,000 cases in the State of Ohio with the death count over 5,000. He said Summit County has about 5,900 reported cases and over 260 deaths. He asked to please continue to follow all mandates and regulations. He said there is a lot of information floating out there and we are many months into this and it is difficult to get use to the new norm and live strictly by the mandates. He said they are doing a good job here in Barberton and the County and the numbers are up mostly across the country. He said they keep stats on everything and keep in contact with Summit County, Summit County Health Department, Summit County EMA, State of Ohio, briefings from the Whitehouse and everyone in between. He said if you have any questions, something you hear or something you see on social media, before you pass it along make sure it is accurate information.

Mrs. Frey asked the Mayor to confirm the email address for the tax levy.

Mrs. Debevec asked the Mayor if he had any idea of what may have prompted the initiation of a new testing site at the CVS in Barberton – if they should warn residents. He said he isn't sure exactly why but CVS across the board has been used as a testing site throughout the county and they may have just been on the list. He stated test kits and testing capacity has always been questioned and been in need. He said Access Point in Barberton and Rite Aid on South Main

Street have also been doing testing. He stated the addition of CVS only helps. She said she totally agrees.

Mr. Heitic stated he wanted to piggyback the Mayor and add that there are multitude of levies in the county, actually 22 of them on the ballot and of that 22 there are 2, 3-year ones and they are anywhere from 3, 5, 7 and permanent. He stated out of the 22 levies, only the City of Barberton and another jurisdiction is asking for a 3-year levy.

President Megyes asked Mayor Judge the date and time of the Relay for Life Race. Mayor Judge stated it is on the 24<sup>th</sup> at 8 A.M.

It was moved by Mrs. Debevec, seconded by Mr. Heitic, to enter into Executive Session for Security Matters – Pending Litigation. All Members voted "yea." Motion carried.

Adjourned into Executive Session at 7:05 P.M. Returned to Legislative Session at 7:17 P.M.
