

**RESOLUTION NO. 225-2012**

**TITLE: INTERGOVERNMENTAL AGREEMENT  
SUMMIT COUNTY  
LABOR RELATIONS CONSULTING SERVICES**

**A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF BARBERTON TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE COUNTY OF SUMMIT, DEPARTMENT OF HUMAN RESOURCES, TO PROVIDE LABOR RELATIONS CONSULTING SERVICES IN THE CITY’S COLLECTIVE BARGAINING NEGOTIATIONS WITH THE OHIO PATROLMEN’S BENEVOLENT ASSOCIATION (OPBA), FOR A FEE OF \$60 PER HOUR, AND DECLARING AN EMERGENCY.**

**WHEREAS,** the County of Summit maintains and operates a Department of Human Resources which conducts said collective bargaining negotiations; and

**WHEREAS,** the City of Barberton wishes to have Summit County provide collective bargaining negotiations and labor relations consulting services in its collective bargaining negotiations with the Ohio Patrolmen’s Benevolent Association (OPBA); and

**WHEREAS,** in exchange for said labor consulting services, Barberton will pay the County a fee of \$60.00 per hour; and

**WHEREAS,** it is necessary for the parties to execute this Intergovernmental Agreement to set forth the rights and duties of the parties concerning the provision of labor consulting services by the County to Barberton; and

**WHEREAS,** this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the City of Barberton to authorize the Mayor to execute an Intergovernmental Agreement between the City of Barberton and Summit County for the aforementioned purposes.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Barberton, State of Ohio:

**SECTION 1.** That this Council hereby authorizes the Mayor of the City of Barberton to enter into an Intergovernmental Agreement with the County of Summit, Department of Human Resources, to provide labor relations consulting services in the City’s collective bargaining negotiations with the Ohio Patrolmen’s Benevolent Association (OPBA), for a fee of Sixty Dollars and No Cents (\$60.00) per hour, according to the terms in the attached Intergovernmental Agreement.

**SECTION 2.** That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public in compliance with the law.

**SECTION 3.** That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, convenience and welfare of the City of Barberton and the inhabitants thereof, for the reason that these services may be needed within the next 30 days, and provided it receives the necessary votes required by the City Charter, shall be in full force and effect from and after its passage and approval; otherwise to be in full force and effect from and after the earliest period allowed by law.
