RESOLUTION NO. 115-2022

PRESENTED BY MR. HEITIC TITLE: TAX LEVY POLICE

A RESOLUTION TO AMEND RESOLUTION NO. 95-2022 TO CORRECT ERRORS IN DRAFTING THE PRIOR RESOLUTION BY ADDING THE REQUIRED LANGUAGE TO SECTIONS 2 AND 3 AND DECLARING IT NECESSARY TO SUBMIT THE QUESTION OF AN ADDITIONAL TAX LEVY IN EXCESS OF THE TEN-MILL LIMITATION FOR THE PURPOSE OF THE ACQUISITION, CONSTRUCTION, IMPROVEMENT, OR MAINTENANCE OF BUILDINGS, EQUIPMENT, AND SUPPLIES FOR POLICE PURSUANT TO SECTION 5705.19(ZZ) OF THE REVISED CODE, AND DECLARING AN EMERGENCY. AS AMENDED ON THE FLOOR TODAY.

The Clerk noted that Council Rule 702 was invoked during the Committee Meeting to suspend Council Rule 302, the 10-day Rule.

Mrs. Coburn make a motion to invoke Council Rule 702 to suspend Council Rule 304, Not on the Agenda. Mrs. Thompson seconded Mrs. Coburn's Motion. All members voting "Aye," Motion Carried.

Mrs. Coburn made a motion to invoke Council Rule 702 to suspend Council Rule 401, Not Called for in Committee of the Whole. Mrs. Thompson seconded Mrs. Coburn's Motion. All members voting "Aye," Motion Carried.

It was moved by Mrs. Coburn, seconded by Mrs. Thompson, that the rule as required by Section 5.10 of the Barberton City Charter be suspended. Members Mrs. Thompson, Mr. Griffin, Mrs. Frey, Mrs. Angeloff, Mrs. Coburn, and Mrs. Bailey voted "Yes" Mr. Jaber voted "No" and Mr. Heitic was absent. President Greer requested the count on the vote for the record. The Clerk stated it was Six (6) yes votes. One (1) No Vote and One (1) member absent. Motion carried. It was moved by Mrs. Coburn, seconded by Mrs. Thompson, that **RESOLUTION NO. 115-2022 BE ADOPTED**.
