

ORDINANCE NO. 09-2020

**TITLE: DISPOSAL OF VEHICLES
POLICE DEPARTMENT**

AN ORDINANCE AUTHORIZING THE POLICE CHIEF TO SCRAP/SALVAGE TWENTY-SEVEN (27) VEHICLES DEEMED TO BE NO LONGER NEEDED FOR ANY MUNICIPAL PURPOSE AND UNFIT AND UNSAFE FOR DISPOSAL IN ANY OTHER MANNER, AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Barberton, State of Ohio:

SECTION 1. That Council hereby authorizes the Police Chief to scrap/salvage the following twenty-seven (27) vehicles deemed to be no longer needed for any municipal purpose and unfit and unsafe for disposal in any other manner, by selling as scrap to the business giving the highest rate of return:

SECTION 2.
