WHEREAS, During her time on the department, Laura has worked on all three patrol shifts, the Detective Bureau, in dispatch and has been on Bike Patrol. Laura holds a special place in her heart for kids and has been a long time member of the Ohio Police Juvenile Officers Association; and

WHEREAS, Laura's personnel file is replete with thank you notes for her professional assistance and service including (8) commendations including apprehending an armed robbery suspect, saving a choking 1 year old and saving two kids from a house fire.

WHEREAS, Laura will be spending her retirement with the two men in her life, her husband and son, along with continuing to cheer on her Cleveland Browns and having a glass of vino or finely crafted lager. Laura's smile and laugh along with her truly caring and compassionate heart will be greatly missed.
