**WHEREAS**, the 2016 Barberton Magics Football Team and their coaches have distinguished themselves through their performances and achievements during the 2016 Football Season; and

**WHEREAS**, the 2016 Barberton Magics Football Team and their coaches have brought recognition to the City of Barberton and have been a source of great pride to the community and its’ citizens; and
