

RESOLUTION NO. 129-2017

TITLE: CERTIFYING PROPERTY TAX RATES

A RESOLUTION ACCEPTING THE AMOUNTS AND RATES OF PROPERTY TAX AS DETERMINED BY THE BUDGET COMMISSION OF SUMMIT COUNTY, AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE SUMMIT COUNTY AUDITOR FOR THE YEAR 2018, AND DECLARING AN EMERGENCY.

WHEREAS, this Council, in accordance with the provisions of law, has previously adopted a tax budget for the next succeeding fiscal year commencing January 1, 2018; and

WHEREAS, the Budget Commission of Summit County, Ohio, has certified its action thereon to this Council, together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof without and what part within the ten-mill limitation.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Barberton, State of Ohio, that the amounts and rates as determined by the Budget Commission on its certification be and the same is hereby accepted.

SECTION 1. That there be and hereby the same is levied on the tax duplicate of said City the rate of each tax necessary to be levied within and without the ten-mill limitation as follows:

SECTION 2. That the Clerk of Council, be and the same, is hereby authorized and directed to certify a copy of this resolution to the Summit County Auditor.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public in compliance with the law.

SECTION 4. That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, convenience and welfare of the City of Barberton and the inhabitants thereof, for the reason that the City desires to file this Resolution with the County within 30 days, and provided it receives the necessary votes required by the City Charter, shall be in full force and effect from and after its passage and approval; otherwise to be in full force and effect from and after the earliest period allowed by law.
