AN ORDINANCE TO AMEND SECTION 1320.01(6) OF THE BARBERTON DEVELOPMENT CODE BY INCLUDING THE "DEVELOPMENT CODE FEE SCHEDULE" IN THE BARBERTON DEVELOPMENT CODE; AND TO AMEND THE DEVELOPMENT CODE FEE SCHEDULE (ORD. NO. 30-2009) TO INCLUDE "VACATIONS OF STREETS, ALLEYS AND PUBLIC AREAS," WITH A \$300 APPLICATION FEE.

That Council hereby amends Section 1320.01(6) of the Barberton Development Code to include the Development Code Fee Schedule in the Barberton Development Code; and hereby amends the Development Code Fee Schedule (Ord. No. 30-2009) to include "Vacations of Streets, Alleys and Public Areas," with a Three Hundred Dollar and No Cent (\$300.00) application fee, and which now reads as follows:
