

**ORDINANCE NO. 39-2015**

**TITLE: AMENDING ORDINANCE NO. 97-2011  
COMPENSATION FOR ELECTED OFFICIALS**

**AN ORDINANCE AMENDING ORDINANCE NO. 97-2011 TO ESTABLISH THE COMPENSATION FOR CERTAIN ELECTED OFFICIALS AND COMPENSATION PROCEDURES FOR THE NEXT FOUR YEARS, AND DECLARING AN EMERGENCY.**

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Barberton, State of Ohio:

**SECTION 1.** That Council hereby amends Ordinance No. 97-2011, “Compensation for Elected Officials,” which established the compensation for the following elected officials for the four year term beginning 2016 and ending December 31, 2019, to now read:

**SECTION 3.** That nothing in this Ordinance shall cause a change in the compensation of the Mayor, Finance Director, Director of Law, and Members of Council during their respective terms due to prohibitions under the Charter and state law.

**SECTION 4.** That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public in compliance with the law.

**SECTION 5.** That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, and for the reason that it concerns the efficient operation of the City, for the reason that compensation of elected officials must be fixed 120 days prior to the general election to be held on November 10, 2015, and provided it receives the necessary votes required by the City Charter, and it shall, therefore, be in full force and effect immediately upon its passage and approval by the Mayor.
