ORDINANCE NO. 47-2015

TITLE: 2015 SIDEWALK REPLACEMENT AND FILL-IN PROGRAM

AN ORDINANCE ESTABLISHING THE CITY'S CONTRIBUTION TO THE 2015 SIDEWALK REPLACEMENT AND FILL-IN PROGRAM, ONLY TO THE PROPERTIES AS LISTED ON THE ATTACHMENT, AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Barberton, State of Ohio:

SECTION 1. That pursuant to Section 668.01(c) of the Barberton Codified Ordinances adopted in Ordinance No. 9-1995 and Ordinance No. 31-1995, Council desires in 2015 to assist property owners, the properties as listed on the Attachment, wherein the property is primarily used as a single or two-family dwelling, in repairing damaged sidewalks abutting their property and in installing sidewalks by contributing forty percent (40%) of the contract bid price obtained by the City.

SECTION 2. That Council's commitment to contribute this amount shall expire upon depletion of the Sidewalk Replacement Fund and Sidewalk Fill-In Fund established in the 2015 Budget.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public in compliance with the law.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, convenience and welfare of the City of Barberton and the inhabitants thereof, for the reason that this program commence as soon as possible in order to assist property owners in repairing damaged sidewalks, and provided it receives the necessary votes required by the City Charter, shall be in full force and effect from and after its passage and approval; otherwise to be in full force and effect from and after the earliest period allowed by law.
