

ORDINANCE NO. 47-2021

TITLE: AMENDING ORDINANCE NO. 54-2019
COMPENSATION FOR ELECTED OFFICIALS

AN ORDINANCE AMENDING ORDINANCE NO. 54-2019 TO ESTABLISH THE COMPENSATION FOR CERTAIN ELECTED OFFICIALS AND COMPENSATION PROCEDURES FOR THE NEXT FOUR YEARS, AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Barberton, State of Ohio:

SECTION 1. That Council hereby amends Ordinance No. 54-2019, “Compensation for Elected Officials,” which established the compensation for certain elected officials for the four-year term beginning 2022 and ending December 31, 2025, by showing said amendment with a ~~striketrough~~ for any deletions and **bold** for any additions.

SECTION 2. That nothing in this Ordinance shall cause a change in the compensation of the Mayor, Finance Director, Director of Law, and Members of Council during their respective terms due to prohibitions under the Charter and state law.

SECTION 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public in compliance with the law.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, convenience and welfare of the City of Barberton and the inhabitants thereof, for the reason that compensation of elected officials must be fixed 120 days prior to the general election to be held on November 2, 2021, and provided it receives the necessary votes required by the City Charter, shall be in full force and effect from and after its passage and approval; otherwise to be in full force and effect from and after the earliest period allowed by law.
