WHEREAS, Dave was a member from 1993 through 2004 of the Barberton Fire Public Education Committee, he served as a member of the Barberton and Summit County Technical Rescue Operations Team, the Barberton SWAT Medic ~ being one of the first Tactical Medics in the State of Ohio and also served as the BFFA Local 329 shift representative and Chair of the Safety Committee for many years.
