A RESOLUTION OF THE COUNCIL OF THE CITY OF BARBERTON TO HONOR AND GIVE PUBLIC RECOGNITION TO LIEUTENANT EDWARD PRAMIK FOR HIS 30 YEARS OF DEDICATED SERVICE TO THIS CITY AS A MEMBER OF THE BARBERTON FIRE DEPARTMENT.

WHEREAS, Edward (Ed) Pramik was hired as a Barberton Firefighter on January 6, 1992. He was promoted to Lieutenant on July 10, 2008; and
