SECTION 2. Beginning January 1, 2025 and every January thereafter, an annual increase to the Mayor, Finance Director and Law Director shall be given by calculating the average of all union contracts or 2%, whichever is higher, yearly in perpetuity.

SECTION 3. That nothing in this Ordinance shall cause a change in the compensation of the Mayor, Finance Director, Director of Law, and Members of Council during their respective terms due to prohibitions under the Charter and state law.

SECTION 4. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public in compliance with the law.

SECTION 5. That this ordinance shall be in full force and effect from and after the earliest period allowed by law.
