

**ORDINANCE NO. 38-2025****TITLE: AMENDING ORDINANCE NO. 144-2009  
POSTING PLACES**

**AN ORDINANCE AMENDING ORDINANCE NO. 144-2009 DESIGNATING SIX POSTING PLACES USED FOR PUBLIC NOTICE FOR ALL RESOLUTIONS AND ORDINANCES FOR THE CITY OF BARBERTON, BY ADDING THREE NEW POSTING PLACES, AND DECLARING AN EMERGENCY.**

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Barberton, State of Ohio:

**SECTION 1.** That Council hereby amends Ordinance No. 144-2009 “Posting Places” by showing said amendment with a ~~strike through~~ for any deletions and **bold** for any additions to read as follows:

**SECTION 2.** That Section 1 of Ordinance No. 144-2009 that designates the six (6) public places to be used for the public posting of Resolutions and Ordinances, which now reads as follows:

That the Council hereby designates the following six (6) public places to be used for the public posting of its Resolutions and Ordinances:

1. Barberton Municipal Building, 576 W. Park Avenue
2. Barberton Public Library, 602 W. Park Avenue
3. United States Post Office, Barberton Branch, 531 Wooster Road,

4. Leach’s Meats, 256-31<sup>st</sup> Street, S.W.
5. Giant Eagle, 41-5<sup>th</sup> Street, S.E.
6. North End Fire Station, State Street

**be and the same is hereby amended to read as follows:**

**SECTION 1.** That the Council hereby designates the following six (6) public places to be used for the public posting of its Resolutions and Ordinances:

1. Barberton Municipal Building, 576 W. Park Avenue
2. Barberton Public Library, 602 W. Park Avenue
3. United States Post Office, Barberton Branch, 531 Wooster Rd. W.
4. ~~Leach’s Meats, 256-31<sup>st</sup> Street, S.W.~~
5. ~~Giant Eagle, 41-5<sup>th</sup> Street, S.E.~~
6. ~~North End Fire Station, State Street~~
4. **Barberton YMCA, 500 W Hopocan Ave**
5. **Barberton Active Adult Center , 500 W Hopocan Ave**
6. **Online, Municipal Website**

**SECTION 3.** That the Mayor, or his Designee, is hereby authorized to amend Ordinance No. 144-2009 to designate the following six (6) public places to be used for the public posting of its Resolutions and Ordinances.

**SECTION 4.** That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public in compliance with the law.

**SECTION 5.** That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, convenience and welfare of the City of Barberton and the inhabitants thereof, in order to comply with Section 5.11 of the City Charter stating that six posting places are required, and provided it receives the necessary votes required by the City Charter, shall be in full force and effect from and after its passage and approval; otherwise to be in full force and effect from and after the earliest period allowed by law.
