COMMUNICATION FROM THE BODY

President Greer thanked the Mayor, staff, Councilmembers and visitors for their flexibility in moving the meeting to the Active Adult Center due to the power outage effecting the Municipal Building.

President Greer reminded everyone that next week, June 30th, will be the fifth Monday and that there will be no Council meeting until Monday, July 7th.

COMMUNICATION FROM THE MAYOR

The Mayor also thanked everyone for their flexibility and remarked that he remembered during the Covid epidemic all Council meetings were held in the Active Adult Center so that everyone could be six (6) feet apart.

The Mayor thanked all of the citizens who came to the meeting to voice their complaints on the recent frequent power outages and offered idea on what could be done or what is needed. Several citizens had already contacted First Energy and initiated petitions to be sent to the Public Utilities Commission of Ohio. The Mayor also stated that he is arranging for our representative from First Energy to address the concerns and that he has requested copies of documents regarding the outages and possible causes or findings from First Energy.

Along the same lines, the Mayor stated on the issue of trees within the city, there have been more issues with trees causing issues in the past few months than we have had in the 13 years that Mayor Judge has been Mayor. The Mayor further stated that he is currently working on a legislative request that would require trees that are a hazard to safety and welfare to be trimmed or removed. This has been an ongoing issue and with the current situation with the electric lines it is time. Not all of our city is on the same supply, getting power from the same substation. The Mayor, returning to the tree issue, stated that in our history, trees were planted for specific issues. They designated property lines and marked boundaries. Today, these same trees have aged, become diseased or are obsolete and need removed. The sapling that was planted has grown in size to a six foot in diameter tree and in some cases causing an issue with power lines, root systems and so forth. This is why we are introducing legislation that will "put some teeth" into this issue with some solutions.

So far this year we have received 19.9 inches of rain. In recent storms we have record downfalls within minutes. Our systems are currently handling the situation fairly well. So far this month we have had 3.14 inches of rain. That measurement is a little low due to the fact that the power outage stopped the rain gage. We try to keep track of measurements frequently to be apprised of upcoming possible situations.

The Mayor thanked Council for passing Ordinance 78-2025 regarding the sale of city property. This is a weird and uncommon situation and this was definitely the way to handle it. One parcel was for the structure and the second parcel number was just for the wall. Just a wall. By passing this we can introduce a new business into our downtown.

The Mayor also wanted to thank Council for passing Ordinance 80-2025. This was looked at a few years ago and will now be another tool in our toolbox to revitalize downtown by bringing in new businesses. We have a special downtown and passing this ordinance will help in the efforts to make it even more special.

The Mayor wanted to thank everyone who came out for Change For Change benefiting Magics Ready to Learn. Next month we have a special situation and will be having Change For Change to benefit a young lady who just graduated from Barberton High School who has been diagnosed with ovarian cancer. As soon as details are finalized, we will have more information coming out.

The Street Repaving Program is moving along very quickly. We have a majority of the streets ground down and ready to receive new pavement. There are some spot repairs throughout the community that are being handled as well.

In closing, the Mayor repeated President Greer's comment that there will be no meeting next week.

Councilman-At-Large stated that he wanted to thank the Mayor as Mr. Heitic put out comments and called for emails from citizens regarding the power outages and how they affected them. Mr. Heitic stated that he received numerous emails which he forwarded to the Mayor and the Mayor responded to each one. The Mayor stated this would be a different issue if it were centralized to one section of town but it is not. It is sporadic effecting all areas at different times and durations. The Mayor expressed his gratitude and appreciation for the public and Council coming together to attempt to find a solution. This was a very productive, positive meeting.
