TITLE: AMENDING ORDINANCE NO. 47-2021  
COMPENSATION FOR ELECTED OFFICIALS

AN ORDINANCE AMENDING ORDINANCE NO. 47-2021 TO ESTABLISH THE COMPENSATION FOR CERTAIN ELECTED OFFICIALS AND COMPENSATION PROCEDURES FOR THE NEXT FOUR YEARS, AND DECLARING AN EMERGENCY.

WHEREAS, both At-Large and President Terms end this year and Council is required to update the legislation prior to the General for said seats.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Barberton, State of Ohio:

SECTION 1. That Council hereby amends Ordinance No. 47-2021, “Compensation for Elected Officials,” which established the compensation for certain elected officials for the four-year term beginning 2026 and ending December 31, 2029, by showing said amendment with a ~~strike through~~ for any deletions and **bold** for any additions.

**SECTION 3.** That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public in compliance with the law.

**SECTION 4.** That this ordinance shall be in full force and effect from and after the earliest period allowed by law.
