

**ORDINANCE NO. 128-2025**

**TITLE: AMEND BCO CHAPTER 351  
SECTION 351.13 OVERNIGHT PARKING**

**AN ORDINANCE AMENDING BARBERTON CODIFIED ORDINANCES, CHAPTER 351, SECTION 351.13 “OVERNIGHT PARKING” TO INCLUDE TWO NEW SUBSECTIONS, AND DECLARING AN EMERGENCY.**

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Barberton, State of Ohio:

**SECTION 1.** Council hereby amends BCO Chapter 351, Section 351.13 “Overnight Parking” by showing said amendments with a ~~strike through~~ for any deletions and **bold** for any additions:

**351.13 OVERNIGHT PARKING**

- (B) Between March 1 and December 15 of each year, no person shall park a motor vehicle between the hours of 11:00 p.m. and 7:00 a.m. of the following day on any of the streets and highways of the city that are scheduled to be swept by the city’s street sweeper during that particular eight-hour period as shown on Exhibit A, attached to original Ord. 6-1993, passed 1-11-1993. However, the prohibition set forth in this division (B) shall not apply to ~~Second Street N.W., from Hopocan Avenue to Tuscarawas Avenue. Further, from the Viaduct west to Eighth Street N.W.,~~ the period of prohibited parking will be from 3:00 a.m. until 5:00 a.m.
- (C) **No person shall park a motor vehicle between 2:00 am and 7:00 am on any day on Commercial Downtown zoned streets. In the case of a new Barberton Development Code in which zone names change, the equivalent zone shall apply this Section.**
- (D) **Persons residing in Commercial Downtown zoned buildings may apply for a permit to lawfully park overnight in the Commercial Downtown zoned lots. Such permit shall be issued by the Director of Safety at their discretion. The approved permit shall be displayed prominently in the motor vehicle. In the case of a new Barberton Development Code in which zone names change, the equivalent zone shall apply this section.**

**SECTION 2.** That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public in compliance with the law.

**SECTION 3.** That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, convenience and welfare of the City of Barberton and the inhabitants thereof, for the reason that these measures are facilitated in a timely manner, and provided it receives the necessary votes required by the City Charter, shall be in full force and effect from and after its passage and approval; otherwise to be in full force and effect from and after the earliest period allowed by law.
