COMMUNICATION FROM THE BODY

Mrs. Hager wanted to note that the work being done to State Street is moving along towards completion nicely.

President Greer stated that if the Consent Agenda passes it will save so much time on meetings.

COMMUNICATION FROM THE MAYOR

The Mayor started his comments with corrections to comments made during the meeting on September 2, 2025 by Mrs. Megan Eberhart. The Boards mentioned by Mrs. Eberhart, Utilities Appeal which is in the Charter that the members are appointed by the Mayor and are not approved by City Council as stated. There are three (3) members which meets only when a citizen appeals their utility bill. Council members are copied on the letters regarding the status of appeals. Appeals to the recently passed Trash Container Pull-back Ordinance are handled by the Building and Zoning Appeals Board (BZA). The Flood Action Committee was established in 2012 and members are also appointed by the Mayor and not approved by City Council. The Mayor explained the reasoning and need for this committee and current discussions being held. This committee included City employees who work on repairing roads after flooding. It also included members of the City's Administration, members of our Safety Forces, and employees of the Water Distribution Garage. Over time additional members have been added including members of the EPA, as well as officials from Copley and Norton who are also affected by flooding. Although personnel in these positions have changed, all are still in communication and updated with progress of the existing on-going projects as well as studies regarding future projects.

The Mayor stated that there was a social media post from the West Theater this past weekend regarding sewer backup stating that no one from the City responded to their calls. The Mayor stated that he checked phone logs and records and no contact from them could be located. All lines are still being checked but currently there is no record of any call from them to the City. A work ticket was located at ODOT who then forwarded it to our inspector who forwarded it to Kenmore Construction by email who then forwarded it to the Mayor. The Mayor gave the history and the updates which occurred in that area from the start of the reconstruction to present. This is an on-going process and the City is doing everything they can to help businesses in the city advance.

The Mayor's open office ours the past weekend went very well with 5 citizens coming in to speak with and ask questions. Those issues are being handled currently.

This past week the Mayor attend the Barberton Academic Hall of Fame Luncheon. Many of our alumni were inducted. Our own Marty Eberhart of the Barberton Police Department was inducted as well.

The Mayor stated that last week he attended a press conference in Akron regarding the Unified Early Learning System. Several schools in Akron and one in Barberton are starting this program. This emphasizes from birth to five (5) years of age. This program is at no cost to the City. All data indicates that is a very successful program and will be expanded as local data comes in. It is always great to work with our own Barberton Community Foundation, the City of Akron and Foundations in the Akron Area for the betterment of our youth. The better we can address issues and help our youth when they are young, the better they will succeed as they are adults and more community oriented.

Finally, the qualifications were released and published in the Akron Beacon Journal for bids for the Justice Center Project. Proposals can be submitted starting in October and as results come in, that information will be released.

The Mayor asked if there were any questions. Mr. Harris asked for the names of the persons who sit on the Utility Appeals Commission. The Mayor stated that Dan Betts, Dan Knorr and Eddie Lawson sit on the Utility Appeals Commission and also listed the offices, department heads who are on the Flood Action Commission. Mr. Harris followed up that he has never seen a Nixle put out over an Ordinance and he wanted to know who authorized the Nixle regarding the Trash Pullback Ordinance. The Mayor stated that he did not know at the current time. We are always looking for residents that can see the bigger picture to volunteer for these committees. Ms. Gearhart followed up Mr. Harris's statement that if we put out Nixle messages for every ordinance that passes people would be less likely to see the emergency notifications. Ms. Gearhart also gave an update to the West Theater issue as she had talked to persons from that business.

Mr. Easterling wanted to know if contingency monies were assessed from the current projects as they are finishing up. The Mayor stated where he knew some of the monies were spent on replacement of

curbs and such. Also, Mr. Easterling had previously questioned methods the paving company used and wanted it on the minutes that asphalt was poured and concrete was put on top around casings and that in his opinion they will fail over time and need to be redone. Mr. Shreve stated it was his belief that it would be redone after completion. Mr. Easterling stated that these are failing on Fifth Street.

The Mayor followed up a comment to Ms. Gearhart regarding the ADA ramps on the corner of Wooster Road West and 14th Street NW. These are not yet completed and the issues regarding ease of access will be handled upon completion.

Mr. Heitic made comments that questions or situations regarding the Trash Can Pull Back Ordinance (76-2025) are appealable if citizens receive citations. The Ordinance is directed at habitual offenders. Life happens and if situations arise the citations are appealable. Mr. Heitic stated he is aware of the Utilities Appeal Board and thinks it is a good thing. Ms. Gearhart asked about the steps to appeal a utility bill. The Mayor explained the process. Mrs. Beck attended the most recent appeal meeting and stated she was impressed at the process. Mayor Judge stated that there will be an up coming increase in sewer fees but the City attempts to keep these costs as low as possible.

With nothing further, it was moved by Mr. Heitic and seconded by Mrs. Thompson to adjourn. All Members present voted "Aye".
