MISCELLANEOUS AND UNFINISHED BUSINESS

During this portion of the meeting President Greer scheduled a Council Work Session / Discussion regarding the independent investigation into the placing of the political advertisement into the Parks Fall Program Guide. President Greer explained his reasons for calling the work session. All parties were given their chance to voice their opinions on the actions taken and the results thus far. A complete copy of the discussion is in the audio recording located in the Clerk of Council's Records.

COMMUNICATION FROM THE BODY

President Greer opened the floor to any comments other than what had been discussed in the work session. With no comments from the Body or Department Heads, President Greer stated that he wanted to thanked all persons who have answered calls and explained the Charter Amendments to citizens that have inquired. Mrs. Beck and Ms. Gearhart created a video and posted it which effectively explains the changes and posted it on social media platforms. Citizens have been expressing their appreciation for this explanation.

COMMUNICATION FROM THE MAYOR

The Mayor began his comments by announcing to all those who haven't already observed, Wooster Road West is now open to traffic going both directions. Although not fully complete and the finishing touches are ongoing the detours are now down and normal traffic flow has resumed. The Mayor reminded everyone that this total reconstruction was an \$11,000,000.00 project and that \$9,000,000.00 of that was in the form of grants awarded and received.

Summit County has used many of their AARPA dollars to connect all the safety agencies throughout the county with a fiber ring called Summit Connects. They will be moving into Barberton later this month to install the lines to our Police and Fire stations. This is strictly for first responders and is not open to the public. This will be coming in from the New Franklin area and should only take a couple of months to complete.

With the closure of the government and the questions revolving around SNAP benefits to citizens we have started our food drive a month early. Any non-perishables or toiletries may be dropped off in the Mayor's office and places around town. These items will be given to Barberton Area Community Ministries (BACM) and the Salvation Army to be distributed to our citizens in need. Our drive usually goes for the months of December and January.

Mr. Heitic requested a map of the installation of the fiber ring for First Responders. The Mayor stated the route he believes they are using but will supply a map so that citizens will know if it is the Summit Connects or OMNI Fiber being installed.

Mrs. Thompson questioned if Wooster Road West to Krantz will be paved this year. The Mayor stated that the weather turned sooner than expected so it will be paved in 2026.

President Greer called for, and Mr. Heitic made a motion for a five (5) minute break. The motion was seconded by Mrs. Thompson and with no objections, Council broke for a 5-minute break.

President Greer brought the Meeting back to order at 8:39 P. M.

At this time President Greer requested a motion to go into Executive Session to discuss matters to remain confidential regarding Economic Development. A motion was made by Mr. Heitic and seconded by Mrs. Thompson to exit into Executive Session. All persons not directly involved in the discussion were asked to vacate the chamber. All recording / electronic devices were turned off. Council entered into Executive Session at 8:41 P. M.

Council returned to the Regular Legislative Meeting at 9:16 P. M.

With nothing further, it was moved by Mr. Heitic and seconded by Mrs. Thompson to adjourn. All Members present voted "Aye". Motion carried.
