

ORDINANCE NO. 160 – 2025

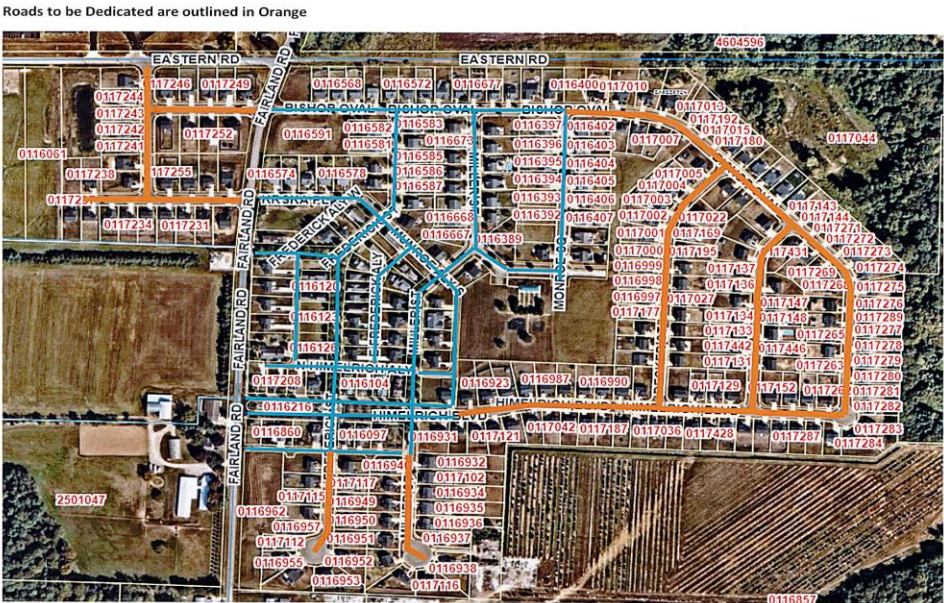
TITLE: STREET DEDICATION
NEW HAVEN EAST AND WEST

AN ORDINANCE ALLOWING THE CITY OF BARBERTON TO DEDICATE ALL ROADS NOT PREVIOUSLY DEDICATED IN NEW HAVEN WEST AND NEW HAVEN EAST (PHASE ONE, TWO, THREE, AND FOUR), AND DECLARING AN EMERGENCY.

WHEREAS, the dedication of Streets will be for the following:

- Bishop Oval at Monroe Square going South East
- Decker Street
- Witner Street
- Himelrigh Blvd starting at Monroe Ally going East
- Frederick Street starting at Himelrigh Alley going South
- Miller Street starting at Himelrigh Alley going South
- Westhaven Ct (West)
- Bishop Oval (West) starting at Fairland Rd and going West to Westhaven
- Krska Place (West) starting at Fairland Rd going West.

WHEREAS, See attached map. Newly dedicated Roads are outlined in orange.



WHEREAS, Planning Staff worked with the various City department (Utilities, Service, Building, and Streets) to ensure that all streets, gutters, lighting, curbs, and all other required infrastructure was installed to code.

WHEREAS, Final inspection was conducted on October 13, 2025 and Planning Commission voted unanimously on October 15, 2025 to dedicate all roads as outlined in the attached maps.

WHEREAS, The dedication of the remaining roads in the New Haven East and West allotment will allow police to start enforcing parking violations, will allow the City to start leaf pickup in the area and snow removal when required.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Barberton, State of Ohio:.

SECTION 1. That this Council hereby authorizes the City of Barberton Planning to dedicated all roads not previously dedicated in New Haven West and New Haven East (Phase one, two, three, and four).,

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public in compliance with the law.

SECTION 3. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, convenience and welfare of the City of Barberton and the inhabitants thereof, in order to facilitate timeliness, and provided it receives the necessary votes required by the City Charter, shall be in full force and effect from and after its passage and approval; otherwise to be in full force and effect from and after the earliest period allowed by law.
