**TITLE: AMEND BARBERTON CODIFIED ORDINANCE
CHAPTER 1060.08 : RESIDENTIAL PAYMENT FEES**

AN ORDINANCE AMENDING BARBERTON CODIFIED ORDINANCES CHAPTER 1060: REFUSE COLLECTION AND DISPOSAL” TO REFLECT A CHANGE IN WORDING FOR SECTION 1060.02(B)(1)(A) “ALLOWABLE WEEKLY PICKUPS”, AND DECLARING AN EMERGENCY.

WHEREAS, the fee changes are necessary in order to maintain the same level of service, offset costs related to operating expenses, and offer various programs and emergency services that rely on sanitation services; and

WHEREAS, the fee changes are pursuant to the new Ordinance titled “Enter into Contract – Kimble Recycling & Disposal, Inc”.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Barberton, State of Ohio:

SECTION 1. That Chapter 1060.08 “Residential Payment Fees” be amended to reflect a change in wording, by showing the following additions in **bold print** and deletions with ~~striketrough~~ pursuant to the new Ordinance titled “Enter into Contract – Kimble Recycling & Disposal, Inc”.

1060.08 Residential Payment Fees

(A) Residents of the city will be charged as provided in the rate schedule (A)(1). Residents participating in the "Barberton Residential Services Relief Program" are eligible for a reduced fee per the rate schedule (A)(1). The fees provided by the rate schedule (A)(1) shall be included in monthly utility bills received by customers.

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public in compliance with the law.

That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, convenience and welfare of the City of Barberton and the inhabitants thereof, to ensure the changes take place in a timely manner, and provided it receives the necessary votes required by the City Charter, shall be in full force and effect from and after its passage and approval; otherwise to be in full force and effect from and after the earliest period allowed by law.
