A RESOLUTION OF THE COUNCIL OF THE CITY OF BARBERTON TO HONOR AND GIVE PUBLIC RECOGNITION TO TAYLER THOMPSON FOR HER DEDICATION TO SERVING ON BARBERTON CITY COUNCIL, AND TO THE BARBERTON COMMUNITY.

WHEREAS, Tayler Thompson has dedicated her time and commitment to serving on the Barberton City Council as the Finance Chair; and

WHEREAS, in addition to serving as the Chair for the Finance Committee, Mrs. Thompson was co-chair of the Planning Committee and served on the Health and Social Services Committee; and

WHEREAS, Tayler Thompson was elected by the City of Barberton residents serving as an at-large position from 2022-2025; and

WHEREAS, Tayler is happily married to Mike Thompson and has 6 children between the two of them; Alyssa, Andrew, Madelyn, Michael, Leah, and Brianna; and

WHEREAS, Alyssa is raising a family of her own here in Barberton, Andrew is serving our country in the US Army, Madelyn is a Sparkles cheerleader and enjoys volunteering at church, Michael loves to play baseball and is a member of Good News Club at school, Leah is a member of (Kiwanis) K-kids and drum club at school and also enjoys playing softball, and Brianna is in Kindergarten and loves volunteering with her mom, dad, and siblings; and

WHEREAS, Tayler is an employee at Barberton Primary School working in a special needs classroom; and

- SECTION 3. That this resolution shall be in full force and effect from and after the earliest period allowed by law.
